Cleveland Ohio USBC Mixed City Tournament Rules (2025-2026 Season)

- 1. This tournament is open to all current members of the Cleveland Ohio USBC (COUSBC). Non-members may enter by purchasing an associate membership (\$28.00) or paying local association dues (\$11.00). Membership dues must be submitted with the entry form. All entries must be completed in full and include the bowler's national USBC ID number. An entry is not considered final until all monies are paid in full.
- 2. This tournament consists of team, doubles and singles events and all-events. Teams consist of 4 players and must be two (2) women and two (2) men. Doubles teams must be one (1) woman and one (1) man. PBA card holders or PWBA title holders are limited to two (2) per team and one (1) per doubles team and are also eligible to enter the singles event and all-events.
- 3. Squad times are as follows:
 - a. 9:00 AM Singles
 - b. 11:00 AM Doubles
 - c. 2:00 PM Team

NOTE: Announcements / practice will be 15-20 minutes prior to the squad time. Scoring will begin at the published squad time (i.e. 9:00 AM, 11:00 AM & 2:00 PM).

- 4. Entry fees and optional event entry fees
 - a. The entry fee is \$40.00 per event and broken down as follows: Lineage: \$12.00; Prize Fund: \$23.00; Expenses/Awards: \$5.00
 - b. Optional Handicap All Events: \$10.00
 - c. Scratch Options: \$5.00 per person per event (team / doubles / singles)
 - Team: \$20.00 (All members must enter for the team to be eligible for the scratch option.)
 - Doubles: \$10.00 (All members must enter for the doubles team to be eligible for the scratch option.)

Singles: \$5.00All Events: \$10.00

Entry fees may be paid by cash, check or money order payable to Cleveland Ohio USBC (COUSBC). Checks returned for non-sufficient funds (NSF) will be charged a \$35.00 fee plus the amount of the check. Only cash will be accepted for NSF checks. No checks will be accepted after October 17, 2025. There will be no refunds (except for illness; see Rule #18). Reserved entries must be filled out completely on the official entry form and submitted with full payment to the COUSBC office (14950 Snow Road, Suite 100, Brook Park, Ohio 44142) by Friday, October 17, 2025. Teams who wish to cross lanes MUST submit their entry forms and payment in the same envelope.

5. Multiple participation will be permitted in each event as follows: In the team event, a team must change two (2) members each time they re-enter. In the doubles event, bowlers may only cash once. If a bowler competes multiple times, their first appearance in each event will be counted towards their all-events score. The prize ratio is as follows: Handicap: At least 1 out of 5 will cash; Scratch: As least 1 out of 5 will cash. Prize money will be returned 100%.

- Tournament winners are determined by the highest handicap series. Winners will be invited to the annual Awards Banquet which will be held at the end of the season.
- 7. Average Rule: All individuals must use:
 - a. Their highest USBC certified average (21 games or more) from the 2023-2024 or 2024-2025 season (including summer averages).
 - b. If the bowler does not have a USBC certified average from the 2023-2024 or 2024-2025 season, they will use their current (2025-2026) average of at least 21 games at the time of bowling. The current average must be verified in writing from the league secretary or the bowler can provide a current standing sheet, which lists the bowler's full name, # of games and current average.
 - c. If the bowler does not have an average as required in 7a or 7b, a 225 average will be used.
 - d. Rule 319-a2 will apply (10-pin rule). (When the previous season's average is used, and at the time of bowling an entrant has a current average for 21 or more games that is 10 pins or more higher than the prior season's average, the current average must be used.)
 - e. Any falsification of average will result in the entrant being disqualified from the tournament.
- 8. HANDICAP will be 90% of 675 for a 3-game series. The team method will be used as follows: Team Event: 90% of 2700; Doubles Event: 90% of 1350; Singles Event: 90% of 675. The handicap game will not exceed 300, and the handicap series will not exceed 900.
- 9. Check-in will be one (1) hour prior to each squad time. All individuals must check-in. Walk-ins are permitted one (1) hour prior to squad time based on lane availability.
- 10. Eligible substitutes will be permitted to bowl in the tournament.
- 11. Bowlers arriving after the squad has begun will be permitted to bowl but must begin in the current frame being bowled. All tardy bowlers not ready to bowl when the squad begins will receive zero (0) for all frames missed.
- 12. Tournament officials will collect money for brackets and jackpots. Brackets will be offered to women and men.
- 13. All bowlers are expected to be appropriately attired. All bowlers must wear a sleeved shirt. Shorts/skorts are permitted; however, length of skirts, dresses, skorts or shorts must be below the competitor's fingertips when they are standing and their arms are hanging down at their side. Length MUST be long enough to not see your bottom area (even if covered by under shorts) at any time, standing or bent over. Apparel with reference to tobacco, alcohol and drugs is prohibited.

The use of non-medical headgear (hats) and/or artificial devices (headphones, AirPods, etc.) to listen to music or a broadcast is prohibited during competition. Cell phones are also not allowed during any competition and includes texting, checking messages, talking on cell phone and listening to music on a device. Bowlers will receive a verbal warning for the first offense; a second offense could lead to disqualification from the event.

Bowlers are responsible for their own conduct during tournament competition. Abuse of equipment and foul or disruptive language/behavior by bowlers or spectators is prohibited. Apparel and behavior violations may result in the non-refundable dismissal from participation or attendance at the tournament. The decision of the tournament director is final. One lane courtesy will be observed by bowlers and enforced throughout the tournament.

- 14. Bowling equipment must meet USBC specifications. No balance holes will be permitted. All holes drilled must be used for gripping purposes on every delivery. NOTE: House balls are exempt from this rule. The use of any powder or foreign substance on shoes, on the approach, on the facility floor, on the carpet, or on a bowling towel is not allowed. Use of all liquids, sprays and sanding pads must be done prior to the first ball of tournament competition. NOTE: Any cleaner that is used prior to the start of competition must be approved by USBC (refer to the "Approved Cleaners" list in the Equipment Specifications manual on www.bowl.com) and in its original container which displays the USBC Approved Before/After logo. Once competition has begun, the outer surface of the bowling ball may only be cleaned with a dry towel (USBC Rule 18). (Competition starts once any bowler throws a ball for score in the tournament.) If a bowler is seen altering a ball surface during the tournament, the ball will be disqualified for the remainder of the tournament as soon as this is discovered. If the bowler incurs a second equipment offense, the bowler will be disqualified from the current event with NO refund of entry fee. NOTE: Should a foreign substance appear on the outer surface of a bowling ball which cannot be removed with a dry towel, an approved cleaner may be used with consent from the tournament manager.
- 15. If a lane malfunction occurs during tournament competition that requires participants to be moved to a new pair of lanes, the participants will start their tournament competition from the point of interruption with no practice/shadow balls on the new lanes. NOTE: The tournament director / official may authorize participants on the pair to practice prior to resuming the game/series.
- 16. The entrant, by signing his/her name, hereby agrees that the COUSBC, its officers and agents shall be liable only to the extent of returning the entry fee if and when this entrant shall be prevented from bowling in the tournament through delay, unexpected yet necessary schedule change, or premature termination of the tournament, which may be brought on by war, national emergency or emergencies caused by unexpected weather conditions or causes relating thereto or resulting therefrom fires, strikes, lockouts, labor difficulties or causes beyond the control of the COUSBC.
- 17. Decisions of the tournament director are final unless an appeal is made in accordance with Rule 329 and is filed within 72 hours of the infraction or prior to tournament prizes being paid, whichever occurs first.
- 18. <u>Illness Precautions</u>: If you are feeling sick, have a fever over 100 degrees or have come in contact with someone who has had a confirmed case of COVID within the last 14 days leading up to this tournament, please contact the COUSBC Office to withdraw from the event. You will receive a full refund.
- 19. All participants agree to allow his/her name and likeness to be used on social media in regard to this event.
