



## **CLEVELAND OHIO USBC HALL OF FAME MERITORIOUS SERVICE**

The Cleveland Ohio USBC (COUSBC) shall have a Hall of Fame for Meritorious Service. In order for an applicant to be considered for candidacy in the COUSBC Hall of Fame for Meritorious Service, he/she must meet a minimum of the following qualifications.

Nominees must have:

- Served as an officer or director of the COSUBC and/or its predecessors.
- Worked on various committees for the COUSBC and/or its predecessors.
- Service to COUSBC and/or its predecessors through working sponsored events.

### **RULES**

1. There shall be no limit to the number of nominees elected to the COUSBC Hall of Fame for Meritorious Service.
2. The nominee must have been an adult member of the COUSBC (and/or its predecessors) for at least fifteen (15) years.
3. Nominees who are currently under suspension are ineligible.
4. Nominees shall continuously be an ambassador in the sport of bowling by exemplifying good character on and off the lanes.
5. The above requirements remain subject to waiver by the COUSBC Hall of Fame Committee.
6. A nominee's name may be submitted by any individual for nomination to the COUSBC Hall of Fame.
7. All nominations must be completed annually on the form provided by the COUSBC and submitted no later than February 28<sup>th</sup> of each year. The envelope should be addressed as follows:

8. All nominations must be submitted with complete and concise records which have been substantiated therein with dates, titles and events.
9. In order to be elected to the COUSBC Hall of Fame, a nominee must receive votes from five (5) out of seven (7) members of the COUSBC Hall of Fame Committee. If no nominee receives the required number of votes, no nominee will be elected.
10. The COUSBC Hall of Fame Committee shall be appointed annually by the COUSBC President. The committee is responsible for reviewing applications and then submitting their recommendations to the COUSBC Board of Directors for final approval.
11. Names and qualifications of nominees not elected to the COUSBC Hall of Fame in the year they are submitted will be kept on file for a period of five (5) years and reviewed annually.
12. All nominees will be notified by mail and/or e-mail of the status of their application.
